In addition, in the event of any action being commenced, the Releasees and myself hereby indemnify the Releasees against any cost and damages arising from or connected therewith. 5. Releasees reserve the right to combine or cancel divisions.

DEFINITIONS

a) "Personal Injury" has its ordinary English meaning and includes any injury for which a person might be awarded General Damages and/or Special Damages at Common Law. b) "The Releasees" means by family, dependants, heirs, executors and/or assigns any person or persons claiming through them. c) "Releasees" means any corporation, association or other body and/or person or persons jointly and/or severally and whether servants or agents of any of the aforementioned or otherwise where any such corporation, other body or individual is associated with the promotion or conduct of the tournament and includes competitors, referees, and observers or members of the audience. d) "Any action" means any claim, right and/or cause of action for damages at Common Law or pursuant to any statute. e) "The Rules" means the rules for the time being of the Australian Karate Federation Incorporated, however, face masks, and body protectors are optional (i.e. not compulsory) for 15 years of age and under.
